


activities. This also includes reimbursement for purchase of ore set of text books and notebooks, two sets of uniforms and one set of school shoes which can be claimed for a child, in a year.

The annual ceiling fored for reimbursement of Children Education

Under this scheme, reimbursement can be claimed once every quarter. The amount that can be claimed in a quarter could be more than Rs.3000, and in another quarter less than Rs.3000, subject to the annual ceiling of Rs 12000 per child being maintained.

- (h) In case both the spruses are Government servants, only one of them can avail reimburgement and a Children Education Allowance.
- (i) Hostel subsidy will be reimbursed upto the maximum limit of Rs.300) per month per child subject to a maximum of 2 children. However, both hostel subsidy and Children Education Allowance cannot be availed concurrently.
- (j) The above limits would be automatically raised by 25% every time the Dearness Allowance on the revised pay structure goes up by50%.
- 2. In order to ensure that Government servants have no difficulty in claiming reimbursement, the procedure under this Scheme is being kept simple. Reimbursement should henceforth be made on the submission of original receipts on the basis of self-certification by the Government servant.
- 3. These orders shall be effective from 1st September, 2008.
- 4. Insofar as persons serving in the Indian Audit and Accounts Department are concerned, these orders issue in consultation with the Comptroller and auditor General of India.
