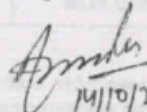

- Recommendations of the Sixth Central Pay Commission.

Consequent upon the decision taken by the Government on the recommendations of the Sixth Central Pay Commission relating to the grant of Conveyance Allowance and in partial modification of Board's letter No. F (E) 1/2000/AL-7/4 dated 31.05.2001, the President is pleased to revise the rates of Conveyance Allowance to Railway employees admissible under Rule 1606 (4) of IREC Vol.II (2005 Edition), as under:-

Average monthly travel on official duty	FIXED CONVEYANCE ALLOWANCE	
	For journeys by own motor car (In Rs. per month)	For journeys by other modes of conveyance (In Rs. Per month)
201-300 Kms	1120	370
301-450 Kms	1680	480
451-600 Kms	2070	640
601-800 Kms	2430	750
Above 800 Kms	3000	850

- The rate of this allowance will be increased by 25% whenever the Dearness Allowance payable on the revised pay scales goes up by 50%.
- The other terms and conditions for the grant of this allowance will remain unchanged.
- These orders will be effective from 1st September, 2008.
