**Sub: Implementation of Government's decision on the recommendations of the Sixth Central Pay Commission- Revision of pension of pre-2006 pensioners/family pensioners etc.**

In pursuance of Government's decision on the recommendations of Sixth Central Pay Commission, the Department of Pension & Pensioners' Welfare (DOP&PW), vide their O.M. No. F.No.38/37/08-P&PW (A) dated 1<sup>st</sup> September, 2008, has issued instructions for revision of pension of pre-2006 pensioners/family pensioners, which are available on websites (i) india.gov.in and (ii) finmin.nic.in. In terms of para 2.1 of the O.M., the instructions contained therein apply to all pensioners/family pensioners, who were drawing pension/family pension on 1.1.2006 under the Central Civil Services (Pension) Rules, 1972, CCS(Extraordinary Pension) Rules and the corresponding rules applicable to Railway pensioners. The corresponding rules applicable to Railway pensioners/ family pensioners are Railway Services (Pension) Rules, 1993, and Railway Services (Extraordinary Pension) Rules, 1993. A copy of said O.M. may be downloaded and in compliance with the instructions contained in paras 11 & 12 thereof, action to issue revised PPCs, in respect of Railway Pensioners/family pensioners, wherever necessary, taken as expeditiously as possible.
