**Sub.**—Payment of advance of travelling allowance to the Central Government servants deputed for Election duties in connection with the General Elections, 1962.

**Sub.**—Payment of advance of travelling allowance to the Central Government Servants deputed for Election duties in connection with the General Elections, 1962.

**Sub.**—Payment of advance of travelling allowance to the Central Government servants deputed for election duties in connection with the General Elections, 1962.

I am directed to state that it has been brought to notice of the Government of India that great difficulty is experienced by the State Government in adjusting most of the advances of travelling allowances made by them to the Central Government servants performing election duties, as the recipients of such advances do not submit their adjustment bills for a considerable period. The Government of India have carefully considered the matter and have decided that the State Government making advances of travelling allowance to the Central Government servants in connection with the forthcoming General Elections should furnish to the Central Government department/office concerned a statement showing the names of the persons and the amounts of travelling allowance advances paid to them. The Head of the Department/Office will thereupon ensure that every person who received such advance submits the necessary adjustment travelling allowance bill well in time and in any case not later than the close of the current financial year. If, however, the Central Government servant fails to submit the adjustment bill within the stipulated time, the Head of the Department/Office will recover the amount of advance from him in cash for credit to the State Government.
