In case, any of the CR(s) is not written /not available, the CR(s) for the preceding year(s) may be sent along with certificate of non-availability etc.

2.1. The bench mark for promotion from Group 'C' to Group 'B' service is 'GOOD'. The last 05 years CRs i.e. period ending 31.03.2011 to 31.03.2015 are to be considered by the Selection Committee. It may be ensured that the photocopy of the CR has been provided to the employee and representation, if any, received within the stipulated period has been disposed off.


2.2. It has also been mentioned that the competent authorities considering representations of the employees against entries/grading in their ACRs/APARs should be informed that the decision on the representation may be taken objectively after taking into account the views of Reporting/Reviewing officers, if they are still in service and in case of up gradation of the final grading given in the ACRs/APAR, specific reasons therefore may also be given in the order of the competent authority.

3. In compliance of instructions contained in PS No: 10517 the above named candidates, before being allowed to appear in the Viva-voce test, are required to undergo the prescribed standard of Medical Examination in terms of Para 530 (a) of IRMM – Vol. I, Third Edition, 2000. In pursuance of instructions contained in PS No: 11149 the authority conducting the medical examination should clearly certify whether the candidate concerned is "FIT" for Group 'B' Gazetted – Technical post of ACM/NR. While examining the candidates medically the instructions as contained in Railway Board's letter NO: 99/H/5/3 dt: 21.05.1999 and 18.12.2000 circulated under this office letter o: 807-E/473-Pt.7/Eia dated 11.12.2001 may also be kept in view.

4. The Service Records duly completed in all respect, Medical Memo in original along with one photo copy duly attested & D&AR clearance, indicating whether any of the candidates is undergoing punishment effecting such promotion or otherwise, may be sent to this office latest by 25.01.2018 under the signature of Gazetted Officer. It may be ensured that date of promotions in Gr. Rs. 7450-11500 & 6500-10500/9300-34,800 GP 4600 - is recorded in the Service record.
