Sub:-Selection for promotion from Group - 'C' to Group - 'B' to post of ACM/N. Railway against 30% quota vacancies (LDCE) for the assessment year 01.01.2018 to 31.12.2019 in the Commercial Department Northern Railway. (Grade Rs. 9300 - 34800 with Grade Pay Rs. 4800/- Pay Matrix level - 08).

1. In continuation to this office letters of even no. dated 07-09-2018, 08-10-2018 and 10.10.18 the competent authority has decided to hold written examination to the Group 'B' post of ACM against 30% quota vacancies for the period from **01.01.18 to 31.12.2019**. A total number of 306 Group- "C" of Commercial Department have been found eligible and are called to appear in written test for filling up 07 vacancies (SC=01,ST=NIL,UR=06) which is scheduled to be held on 22-12-2018 at **UPSC, New Delhi**.

2. The written test to be held on 22-12-2018 at Examination Hall of UPSC, Dholpur House Shahjahan Road (near India Gate circle) New Delhi. Entry for UPSC hall will be from Gate No.3.

3. In terms of Railway Board's letter No. E(GP) 88/2/111 dated 20.08.91, circulated under P.S.No.10493, the written test will comprise of two papers and will be held as per details below:-

3. The candidates who qualify the written examination will have to pass prescribed standard of Medical Examination before being called for viva-voce test under para 530-(a) (Technical) of IRMM/2000 under P.S.No.10517 and medically fit candidates will be allowed to appear in the viva-voce test. In pursuance of instructions contained in Northern Railway P.S.No.11149, the authority conducting the

medical examination should clearly certify whether the candidate concerned is 'FIT' for Group-B Gazette. – Technical post for Commercial Department as ACM or otherwise. While examining the candidate medically, the instructions as contained in Railway Boards letter N0. 99/H/5/3 dated 21.05.99 and 18.12.2000 and circulated under this office letter N0.807-E/473/Pt.vii /EiA dated 11.12.2001 may also be kept in view. The provision as laid down in para 529 and 530 (a) read with para 503 of IRMM Volume-1-3 Edition, 2000 may also be referred to.

4. All the SC/ST candidates shown in Annexure-'A' are required to be given pre-selection coaching/ training – as per extant instructions as contained in PS No. 10401 & 11513. All care has been taken to indicate SC/ST status, however, it may also be checked at your end and ensured that no SC/ ST candidates is left out from Pre-Selection-Coaching/ Training and the same may be advised to this office also.

5. Please ensure that acknowledgement is obtained from individual candidates and that complete information i.e. date of written test, venue and time has been communicated to all candidates. An advice to this effect may also be sent to this office.

6. There is no provision of supplementary examination in L.D.C.E, as such no candidate should be held back even on administrative grounds.

7. The staff transferred to other office or proceeded on deputation should be informed at his new official address immediately by the parent department / Office, from where he proceeded.



As the written test is scheduled to be held at examination Hall of UPSC, Shahjahan Road New Delhi, all the candidates concerned may be issued an identity slip, as per ANNEXURE 'B' to this letter, under clear signature. Any candidate reporting without identity slip will not be allowed to enter UPSC premises due to security reasons by the security officials.

9. The syllabus of ACM-30% has already been circulated under NR, P.S. No. 11729

10. **The written test is scheduled to be held on 22-12-2018 at Examination Hall of UPSC, Shahjahan Road (near India Gate circle) New Delhi. Entry for UPSC hall will be from Gate No.3. All 306 candidates may be informed accordingly and directed to appear in written test to be held on 22-12-2018 and to report to UPSC Hall on 8.30 AM sharp.**

11. The all candidates are requested to bring their own pens, pencils, scales, rubber. Only answer books will be supplied by this office. No candidate will be allowed to bring Mobile phones, books and calculator & electronic device etc.
