Sub: Selection for promotion to the post of Asstt. Personnel Officer (Group – 'B') against 70% quota vacancies for the period 01.11.2017 – 31.10.2019 (Written Exam date 07.04.2018).

1. In terms of this of this office letter of even number dated 07.03.18 the date of Written Examination for selection to the Group 'B' posts of APO against 70% quota vacancies has been written as 07.04.17 due to typographical error. However the same is 07.04.2018. To avoid any ambiguity the said notification is re-circulated here under.

In supersession to this office letter of even no. dated 07.03.18, the written examination for selection to the Group 'B' post of APO 70% quota vacancies for the assessment period 01.11.2017 to 31.10.2019 is scheduled to be held on 07.04.2018 at UPSC Hall, New Delhi, for filling up total 13(UR-10, SC-02, S'1=01) vacancies of APO.

All 366 candidates mentioned in **annexure 'A'** of this letter may be informed of date and venue of the written exam to be held on 07.04.2018 at UPSC Hall, Dholpur House, Shahjahan Road, New Delhi. There will be only one written exam which will start at 10:30 hrs.

2. WRITTEN EXAM AND VIVA-VOCE:


The written exam will comprise of only one paper in terms of Railway Board's letter No: E (GC) 88/2/111 dt: 20.08.1991, circulated under PS No; 10493, which will be followed by viva-voce exam for those who will qualify the written exam and pass the prescribed standard of Medical Examination as detailed in Para 530(b) of Indian Railway Medical Manual, Volume – I, Third Edition – 2000. In pursuance of instructions as contained in PS No: 11149 the authority conducting the medical examination should clearly certify whether the candidate concerned is "FIT – for Group 'B' Gazetted Non-Technical post of APO/Group 'B' or otherwise. While examining the candidates medically the instructions as contained in Railway Board's letter No: 99/H/5/3 dt: 21.05.1999 and 18.12.2000 circulated under this office letter No: 807-E/473-Pt.7/EiA Dated 11.12.2001 may also be kept in view.

3. SUPPLEMENTARY WRITTEN EXAM:

If required a supplementary written exam will be held for those candidates who fail to appear in the main written exam to be held on 07.04.2018 due to administrative reasons or on medical grounds provided the Railway Doctor concerned gives a certificate (as per instructions contained in PS No: 4000) that he was aware of the fact that the candidate concerned has to appear in the written exam for which candidate concerned himself has to declare before the Doctor at the time of reporting sick.

4. PRE-SELECTION TRAINING TO SC/ST CANDIDATES:

All the reserve community candidates shown in the enclosed as annexure –'A' are required to be imparted pre-selection coaching/training – as per extant instructions as contained in PS No: 10401 and 11513. The concerned Personnel Officer In charge will be personally responsible to manage the pre-selection-coaching and to spare the staff for pre-selection coaching classes. In case any of the reserve community candidates is not interested for pre-selection-coaching /training, his written refusal may be obtained for keeping in record. All care has been taken to indicate reserve community candidate status;

however, it may also be checked at your end and ensured that no reserve community candidate is from pre-selection-coaching/training.

A certificate to the effect that all the candidates belonging to reserved community available in the enclosed list have been imparted Pre-selection coaching may be sent to this office latest by 16.03.18.

The staff/ candidates who are on deputation with other departments/ Ministries and have applied to appear in the present selection must be informed well in time about date of written exam venue & time by the office concerned from where they proceeded on deputation & such candidates belonging to reserved community (SC/ST) may also be given pre selection coaching well in time.

Such of the staff who also have an avenue of promotion to Group 'B' in their own department shall have to exercise an option within 30 days of their being empanelled for the post of APO regarding their further promotion as Assistant Personnel Officer/Group "B" or otherwise. Option once exercised shall be final.

The Railway Board has issued revised syllabus vide its letter No. E(GP)2013/2/24 dated 02.12.2014 for selection to the Group 'B' post of APO against 70% and 30% quota vacancies the same has been circulated vide this office letter No. 844E/Misc/PS/EiA dated 07.01.2015, under N.Rly. P.S. No. 14300/2015.

All the 366 (three hundred & sixty six) candidates as listed in annexure 'A' of this letter may be informed of the date/time & venue of the written test and may be directed to report at the venue viz. Union Public Service Commission, Dholpur House Shahjahan Road New Delhi 110069 latest by 09:30 hrs. Entry for UPSC Hall No. 1 & 2 will be from Gate No. 3, on 07.04.2018 (Saturday).

The candidates who have since retired/ resigned etc. will not be eligible to appear in the present selection.

No candidate may be held back even on Administrative grounds. Beside, certificate of having imparted Pre-selection coaching to reserved community candidates may be provided to this office well before 07.04.2018.

Keeping in view that the written test is to be conducted in UPSC, hence for the security reasons the:-

- i. Candidates may be issued identity slips, containing their latest photograph duly attested by officer concerned as per Annexure 'B' of this office letter. Any candidate reaching to the venue without identity slip will not be permitted by UPSC authorities to enter the premises and this office will bear no responsibility.
- ii. The candidates appearing in the written examination are required to bring their own pens, pencils, scales, rubber etc. This office will supply only answer books.
- iii. Mobile Phones or other electronic devices are not allowed inside the examination hall.
- iv. The candidates can use only blue or black pen in the above written exam.

All the terms and conditions stipulated in this office letter of even number dated 01.12.2017 & 16.02.18 shall remain same.
