4. Keeping in view that the written test is to be conducted in UPSC hence for the security reasons:-

The Candidates may be issued 02 (Two) Identity slips containing their Photographs duly attested by the office concerned thereon, as per Annexure of this letter. **Both the identity slips for paper part - I and paper part – II should contain photograph of the candidates, due to security reasons.** Any candidate reaching to the venue without identity slip will not be allowed to enter the UPSC premises due to security reasons by the security officials. 
5. It has already been made clear vide this office letter of even dated 31.05.16 that there is no provision for holding supplementary written test hence no candidates should be held back even on administrative ground.
