2.0 The concerned office may send the **Confidential Reports for the year ending 31.03.2011 to 31.03.2015** in respect of the above candidates to PS-I/CEE latest by 20.02.2017. In case any of the CRs is not available, the CRs for the preceding years may be sent along with certificate of non availability etc.

2.1 The bench-mark for promotion from Group-‘C’ to Group-‘B’ service is ‘Good’. The last 05 years’ CRs i.e. period ending 31.03.2011 to 31.03.2015 are to be considered by the Selection Committee. Necessary action may kindly be taken regarding conveying the CR to the concerned employee in case of below bench mark CR.

2.2 It has also been mentioned that the competent authorities considering representations of the employees against entries/ grading in their ACRs/ APARs should be informed that the decision on the representation may be taken objectively after taking into account the views of Reporting/ Reviewing officers, if they are still in service and in case of up-gradation of the final grading given in the ACRs/ APARs, specific reasons therefore may also be given in the order of the competent authority.

3.0 D&AR/ Vigilance Clearance of the above candidates may also be called and the same must be signed by the Gazetted Officer, while sending the same to HQ Office. It may also be asked from the office to check-up whether the above candidates are undergoing any punishment or not.


4.0 The Service Records duly completed in all respect, Medical Memo in original along with one photo copy duly attested & D&AR clearance, indicating whether any of the candidates is undergoing punishment in D&AR/ Vigilance case effecting such promotion or otherwise, may be sent to this office latest by 20.02.2017. It may be ensured that date of regular promotions in Grade Rs. 6500-10500/ 9300-34800 GP Rs. 4200/- & 4600/- is recorded in the Service Record.

5.0 In compliance of instructions contained in PS No. 10517 the above named candidates, before being allowed to appear in the Viva-Voce Test, are required to undergo the prescribed standard of Medical Examination in terms of Para 530(a) of IRMM–Vol.I, Third Edition–2000. In pursuance of instruction contained in PS No. 11149 the authority conducting the medical examination should clearly certify whether the candidate concerned is “FIT” for Group-‘B’ Gazetted–Technical Post of Assistant Electrical Engineer/ Northern Railway (AEE/N.Rly). While examining the candidates medically the instructions as contained in Railway Board’s letter No. 99/H/5/3 dated 21.05.99 and 18.12.2K circulated under this office letter No. 807-E/473-Pt.7/EiA dated 11.12.01 may also be kept in view.
