2.0 The Confidential Reports for the years 2008-09 to 2012-13 in respect of the above candidates may be sent to **P.S-I/CME/N.Rly. latest by 01.09.2014.** In case any of the CR(s) is not written/available, the CR(s) for the preceding year(s) may be sent along with certificate of non-availability etc.

2.1 The bench-mark for promotion from Gr. 'C' to Gr. 'B' service is 'Good'. The last 05 years CRs i.e. period ending 31.03.06 to 31.03.10 are to be considered by the Selection Committee. Necessary action may kindly be taken regarding providing a copy of the CR to the concerned employee in case of below bench mark CR.

2.2 As per instructions contained in Railway Board's letter No. 2010/SSC/3/8 dated 09.7.10, if any employee is to be considered for promotion in a future DPC and his ACRs prior to the period 2008-09, which would be reckonable for assessment of his fitness in such future DPCs contain final grading that are below the bench-mark for his next promotion before such ACRs are placed before the DPC, the concerned employee will be given a copy of the relevant ACR for his/ her representation, if any, within 15 days of such communication. It may be noted that only below benchmark ACR for the period relevant to promotion need be disclosed.

2.3 It has also been mentioned that the competent authorities considering representations of the employees against entries/grading in their ACRs/APARs should be informed that the decision on the representation may be taken objectively after taking into account the views of Reporting/ Reviewing officers, if they are still in service and in case of up gradation of the final grading given in the ACRs/ APAR, specific reasons therefore may also be given in the order of the competent authority.

3. In compliance of instructions contained in Northern Railway P.S. No. 10517, the candidates concerned before being allowed to appear in the viva-voce test are required to undergo the prescribed standard of medical examination in terms of para 530(a) of IRMM Volume – I, 3<sup>rd</sup> Edition – 2000. In pursuance of instructions as contained in P.S. No. 11149 the authority conducting the medical examination should clearly certify as to whether candidates concerned is "FIT FOR GROUP – B GAZETTED TECHNICAL for Mechanical Department as A.M.E/A.W.M or otherwise". While examining the candidates medically the instructions as contained in Railway Board's letter No. 99 – H – 5 – 3 dated 21.05.1999 & 18.12.2000 circulated under this office letter No. 807 – E/473 – Pt.VII/EiA dated 11.12.01 should also be kept in view.

4. The Medical Fitness Certificate in original may be sent to this office along with one photocopy duly attested by 01.09.2014. Only those candidates who are declared medically "FIT" in the medical examination under the prescribed standard may be directed to this office to appear in the viva-voce.

4.0 D&AR/Vigilance clearance of the above candidates may also be called and the same must be signed by the Gazetted Officer, while sending the same to HQ Office. It may also be asked from the Divisions/ Units to check-up whether the above candidates are undergoing any punishment or not. **It may also be ensured that the vigilance clearance should be furnished by the vigilance office and not be the respective officer.**
