In continuation to this office letter of even number dated 10.08.2017 it has been decided to hold written Examination for Selection for promotion from Group 'C' to Group 'B' service in the Civil Engineering Department as AEN against 30% quota vacancies for the assessment period from 01.07.2017-30-06-2019 to form panel of SC=04, ST=03,UR=14 Total=21(twenty one only) vacancies.
2. WRITTEN TEST AND VIVA-VOCE  
The list of 574 (Five hundred and seventy four only) candidates who have applied in reference to this office letter of even number dated 10-08-17 to appear in the present selection is enclosed as Annexure - "A" of this letter. The list has been prepared on the basis of service particulars verified by the division concerned. The eligibility may again be confirmed at your level as per rules & any discrepancy in the service particulars may be brought out to the notice of this office immediately. In case any of the listed candidates found ineligible at any stage his name will be deleted from the list of eligible candidates without any notice .
3. The written test will be held in the month of April 2018; however the date and venue of written examination will be intimated shortly. Please ensure that contents of this letter are got noted by each candidates and acknowledgement under clear signature to be obtained by the office concerned .

In terms of instructions contained in their Railway Board's letter No: E (GP) dated 20.08.1991, Circulated under N.Rly.P.S No: 10493, the written test will comprise of papers and will be held as detailed below:

Professional Paper-I

(Professional Subject and General Knowledge)

Time 10.00 hrs. to 13.00 hrs.

Professional Paper-II

(Professional Subject and Establishment & Financial Rules).

14.30. hrs. to 17.30 hrs.

4. The selection will comprise of Written Test followed by viva-voce of candidates who will qualify the written test. In compliance of instructions contained in N.Rly PS No: 10517, the candidates who qualify the written examination, are required to qualify the prescribed standard of Medical Examination (Technical) read with Para 530(a) of IRMM/Volume /I Third Edition-2000, before appearing in the viva voce.
5. In pursuance of instructions as contained in Northern Railway P.S No: 11149, the authority conducting the medical examination under Para 530 (a) of IRMM should clearly certify whether the candidate concerned is "FIT - for Group-'B' Gazetted - Technical post for Civil Engineering Department as AEN" or otherwise. While examining the candidates medically the instructions as contained in Railway Board's letter No: 99/H/5/3 dated 21.05.1999 and 18.12.2000 circulated under this office letter No: 807-E/473-Pt.7/EiA dated 11.12.01 may also be kept in view.

6. PRE-SELECTION COACHING:

All the SC/ST candidates shown in Annexure -'A' are required to be given pre-selection coaching/training - as per extant instructions as contained in P.S No: 10401 & 11513. Officers in-charge will be personally responsible to spare the staff for pre-selection coaching classes. In case any of the SC/ST candidates is not interested for pre-selection-coaching /training his written refusal may be obtained and kept in record. All care has been taken to indicate SC/ST status, however, it may also be checked at your end and ensured that no SC/ST candidate is left out from Pre-Selection-Coaching/Training and the same may be advised to this office. It is requested that Pre-selection-coaching may be imparted to the candidates belonging to reserved community candidates and necessary certification of having imparted the same may be sent to this office well before the date of written Examination.

Please ensure that acknowledgement is obtained from individual candidates and that complete information i.e. date of Pre-Selection Coaching has been communicated to all SC/ST candidates. An advice to this effect may also be sent to this office prior immediately..

The Staff/Candidates who are on deputation with other departments/ Ministries and have applied to appear in the present selection (Annexure-'A' of this letter refers to) must be informed well in time, of written test & Venue by the office concerned from where they proceeded on deputation & such candidates belongs to reserved community (SC/ST) may also be given pre selection coaching well in time.
  8. AS THERE IS NO PROVISION FOR HOLDING SUPPLEMENTARY WRITEN TEST, hence no candidate should be held back even on administrative grounds.
  10. The syllabus for written examination, for selection to the post of AEN against 30% quota vacancies has already been issued vide this office letter No. 844-E /MISC/P.S.No. /EIA(2017) dated 05-01-2017, N.Railway PS. No. 14661/2017.
  11. The candidates are required to bring their black/blue Pen, Pencils, Rubber, Scale etc. and this office will provide only the Answer Sheets.
  12. Use of Mobile phone during the course of Written Examination is not allowed and as such bringing mobile phone, electronic device etc. in the Examination Hall is strictly prohibited.
  13. The candidates may be issued 02 (two) Identity slips (Separately for paper-1 & paper -11) containing their Recent Photograph duly attested by the office concerned thereon, as per Annexure -"B" of this letter . Both the identity slips for papers part-1 and papers part-11 should contain photograph of the candidates due to Security reasons. Any Candidates reaching to the venue without identity slip will not be allowed to enter in Examination Hall . The written test will be held in the April of April 2018; however the date and venue of written examination will be intimated shortly.
