In continuation to this office letter of even number dated 10.08.2017 & 06.03.18 the competent authority has decided to hold written examination for selection for promotion from Group 'C' to Group 'B' service in the Civil Engineering Department as AEN against 30% quota vacancies for the assessment period from 01.07.2017 – 30.06.2019 **on 03.11.18, at UPSC, Dholpur House, Sahajahan Road, New Delhi-110069.** In terms of Railway Board's instructions contained in their letter No. E(GP)88/2/111 dated 20.08.1991, Circulated under N.Rly. P.S No: 10493, the written test will comprise of two papers and will be held as detailed below:-

Professional Paper-I

(Professional Subject and General Knowledge)

Time 10.00 hrs. to 13.00 hrs.

Professional Paper-II

(Professional Subject and Establishment & Financial Rules).

14.00. hrs. to 17.00 hrs.

2. As the paper – I will start at 10.00 hrs, the candidates concerned must report at the examination center at UPSC, Dholpur House, Sahajahan Road, New Delhi-110069 latest by 9.00 AM.
3. All the 574 (Five hundred and seventy four only) candidates as per list attached with the letter as Annexure - "A" may be informed accordingly and directed well in time to appear in written test on 03.11.2018 at UPSC, Dholpur House, Sahajahan Road, New Delhi – 110069.
4. The staff transferred to other office or preceded on deputation should be informed at his new official address immediately by the parent department/office, from where he proceeded.



5. Entry for UPSC Hall will be from Gate No. 03 and the candidates are required to report at the venue latest by 09.00 AM. The candidates who have since retired / resigned or transfer from Northern Railway to other Railway on their own request etc. will not be eligible to appear in the present selection.
6. Keeping in view that the written test is to be conducted in UPSC hence for the security reasons:-
The Candidates may be issued 02 (Two) Identity slips (separately) containing their latest Photographs duly attested by the office concerned thereon, as per Annexure "B" of this letter **Both the identity slips for paper part - I and paper part - II should contain photograph of the candidates, due to security reasons.** Any candidate reaching to the venue without identity slip will not be allowed to enter the UPSC premises due to security reasons by the security officials. Mobile Phones/Other Electric devices are not allowed in side of the examination hall.
7. The syllabus for written examination, for selection to the post of AEN against 30% quota vacancies has already been issued vide this office letter No. 844-E/MISC/P.S.No./EIA(2017) dated 05.01.2017, Northern Railway PS. No. 14661/2017.
8. **It has already been made clear vide this office letter of even dated 06.03.18 that there is no provision for holding supplementary written test hence no candidates should be held back even on administrative ground.**
9. The candidates are required to bring their black/blue Pen, Pencils, Rubber, Scale etc. and this office will provide only the Answer Sheets
10. It may be ensured that all the candidates belonging to reserved community & willing for pre selection coaching have been imparted Pre-selection-coaching well before the date of written examination.

All terms and conditions stipulated in this office letter of even dated 10.08.17 & 06.03.18 shall remain the same.
