All the 363 (three thousand & sixty three)candidates as listed in annexure 'A' this office letter of even number dated 16.02.18 may be informed of the date/time & venue of the written test and may be directed to report at the venue (UPSC) latest by 09:30 hrs. Entry for UPSC Hall No. 1 & 2 will be from Gate No. 3

The candidate who have since retired/ resigned etc. will not be eligible to appear in the present selection.


No candidate may be held back on Admn. grounds. Beside, certificate of having imparted Pre-selection coaching to reserved community candidates may be provided to this office well before 07.04.18.

Keeping in view that the written test is to be conducted in UPSC, hence for the security reasons the:-

1. Candidates may be issued identity slips, containing their photograph duly attested by officer concerned as per Annexure 'B' of this office letter of even number dated 16.02.18. Any candidate reaching to the venue without identity slip will not be permitted by UPSC authorities to enter the premises.
2. The candidates appearing in the written examination are required to bring their own pens, pencils, scales, rubber etc. This office will supply only answer books.
3. Mobile Phones or other electric devices are not allowed in side the examination hall.
4. The candidates can use only blue or black pen in the above written exam.

All the terms and conditions stipulated in this office letter of even number dated 16.02.18 shall remain same.
