In partial modification of the instructions contained therein the Railway Board have now decided that the staff governed by the Ex. Co. Leave Rules, including ex. G.I.P. in whose case the unexpired portion of L.P.R. carried forward on re-employment under para 3(i)(b) of their letter No. F (E)59/LE1-(1), dated 13-6-1959 might itself be more than six months, may be allowed the same without applying the limit of 6 months laid down.

In terms of para. 4 of the Board's letter referred to above, at least one half of the prize money is required to be given in the form of Hindi books, the other half in cash. It has been represented to the Board that the percentage of Hindi books in the prize money is rather on the higher side. The position has been reviewed and it has been decided that 75 % of the prize money should be given in cash and 25 % in the form of Hindi books.
