

necessary, the travelling expenses of the subscriber or any person actually dependent on him subject to the following conditions :—

- (a) "the amount of withdrawal shall be limited to six months' pay of the subscriber or fifty percent of the amount of his own subscription alongwith interest thereon, standing to his credit in the fund, whichever is less ;
- (b) in respect of illness of the same person only one withdrawal shall be permissible. Only either a withdrawal under this rule or an advance under rule 1321 shall be allowed at a time ; and
- (c) the subscriber shall furnish a certificate to the sanctioning authority within one month after the course of treatment is over that the amount withdrawn has actually been utilised for the purpose for which it was intended ; any unspent amount being refunded forthwith. If the subscriber fails to give the requisite certificate or fails to refund the unspent amount, the same shall be recovered from him forthwith in lumpsum together with interest thereon at the rate provided for in rule 1319(i) from the month of the withdrawal, for being credited to his account in the provident fund.
