### NOTIFICATION

**Sub:-** Re-engagement of Retired employees in Gati Shakti Unit of LKO Division, Northern Railway.

In terms of Para 3.2 of Railway Board letter under reference, it has been decided to fill up posts in Gati Shakti Unit of LKO Division by re-engagement of retired staffs on monthly remuneration basis. The details of Department and the category of posts, in which Vacancies are proposed to be filled by re-engagement, are as under :-

The re-engagement is subject to the following conditions:-

1. Only the employees retired due to their Superannuation are eligible to apply.
2. The re-engagement shall be strictly up to the age of 65 years or till the posts are filled up by the regularly selected candidates through RRB/RRC/Departmental Selections whichever is earlier.
3. All the railway Retired Supervisor who have not attained 64 years 6 months on the closing date of notification (to ensure at least Six months services is available after re-engagement) for re-engagement purpose will be eligible.
4. The service of re-engaged retired Railway supervisors can be terminated after giving a notice period of one month.
5. The employees who have been removed/dismissed/compulsorily retired as a result of Disciplinary actions or In review & employees retired on Voluntary are NOT ELIGIBLE for re-engagement.
6. Monthly remuneration of a retired Railway supervisors being re-engaged be determined as per NRPS N.15250/2019 dated 18.11.2019.
7. The employee who is re-engaged shall execute an agreement to abide by all the terms & conditions of re-engagement.
8. Re-engagement shall be subject to prescribed medical fitness for the category in which they are re-engaged.
9. Retired employees to be re-engaged should be free from vigilance & DAR cases.

10. Suitability/Competency of the applicant shall be adjudged by nominated committee before their re-engagement.
11. The duty hours of the re-engaged employee would be prescribed by the competent authority as per the working conditions of the post.
12. Applicants should enclose copy of any of the following documents along with their application.
  - i. Service Certificate.
  - ii. Pensioner Identity Card.
  - iii. Pension Payment Order.
13. Retired Railway employees may apply for re-engagement to the post (in which category they have retired) in the enclosed preformed on or before **26.10.2022** in CR Section DRM/Office/LKO.
14. This scheme is valid till further orders.

Notification may be given wide publicity duly displaying on the Notice Board and amongst the retired Railway employees.
