Sub : Approval of Engineering Plans (Other than Track & Bridges).

Ref : Chief Engineer's Circular No. 601-C, dated 22.4.09.

In partial modification to the CE's Circular, issued vide reference above on 22.4.09, Revised Circular on Approval of Engineering Plans, as Chief Engineer's Circular No. 601-C (other than Track & Bridges) is hereby issued as under :

2.	Site plan for quarters / buildings in colony, provided it is in accordance with already approved master plan of colony	Divisional Railway Manager
3.	Site plan of Platform Shelter and Foot-Over-Bridge, provided these are as per detailed drawings approved by HQ Office or RDSO	Divisional Railway Manager
4.	Site plan for structures on platform	Divisional Railway Manager *
5.	Site Plan for construction of staff quarters as per standard type plan, issued by HQ Office	Divisional Railway Manager
6.	General Arrangement Plans/Drawings (GAD) of buildings including additions & alterations.	Concerned THOD after signature of HOD of User Department (IRWM-203)
7.	Extension or Raising of platform, not requiring addition and alteration in yard, based on approved type plan	Divisional Railway Manager
8.	Plan for dismantling of siding	Concerned THOD
9.	Structural drawing for any structure including addition and alteration to an existing structure	Dy. Chief Engineer/P&D However, no building drawing (including that for addition/ alteration) will be approved without relevant design/ drawing being put up to Dy. CE/ P&D. Design should invariably include design of foundation (IRWM-203).



15.	All structures involving departure from type plans issued by HQ or by RDSO	Chief Engineer/P&D

* If the infringement to Schedule Of Dimensions due to any proposed structure (e.g. Platform Shelter, FOB, Lean-to-shed, Water Booth etc.) is unavoidable, plan should be sent to Headquarters Office, giving full justification as to why the infringement cannot be avoided, for processing the case for sanction of competent authority.

Notes :

1. Important stations – All Model & Modern Stations of Northern Railway.
2. Important Colony – Zonal HQ, Divisional HQ, AENS' HQ and any other colony, considered important by Division.
3. All General arrangement Plans/Drawings (GAD) should be prepared on AutoCAD and to be sent to HQ alongwith soft copy.
