33(a). To the payment of arbitration fees to private persons in excess of Rs. 25000/- in each case.

NOTE:

- i) The circumstances under which such appointments of private persons have been made should, however, be brought to the notice of the Board
- ii) This will not apply to payment of fees to Arbitrator's appointed by Court, for which full powers will be exercised by General Managers.

- b) To the payment of arbitration fees to retired railway officers in excess of Rs. 75,000/- Rs. 2,25,000/- per case.

- c) To the payment of Contribution/Subscription to a medical institution if medical aid is rendered by such institutions to Railway employees in excess of Rs.1000/- per annum.

- d) To the payment of Contribution/Subscription to a Professional Institution in excess of Rs.10,000/- per annum in each case. These powers may be delegated to DRMs also.
