Railway board vide letters referred above has directed that the suo moto disclosure information be uploaded by the units and HQs on the website; and, NAI/Vadodara shall conduct third party audit on all Public Authorities over Indian Railways including Zonal Railways (HQ Office)/Divisions/Workshops, PSUs, PUs etc.

2. Since there is no uniformity of disclosure of information across the NR website, so the competent authority viz. AGM/NR has constituted three members committee for suggesting and coordinating modifications/changes in NR website to facilitate uniform navigation and review information to be uploaded on website for disclosures to comply with guidelines as envisaged with aim to enlarge the domain of suo-moto disclosures of information by the respective Public Authorities including third party audit as mandated under Section 4 of RTI act and DOPT OMs referred above.


