In reference to the above, it is to bring on record that in terms of a vigilance case of even no. dt. 21.10.2021, it has been highlighted that **Guards/Train Managers** are claiming **fake mileage** by showing fake movement of Goods/Coaching trains. "Minor penalty" against the erring employee(s) has been advised by NR Vigilance.

In continuation of the same, NR vigilance has advised the following measures to curb the practice of fake mileage claims:-

1. Provision of integration of **Crew Management System (CMS)** with **Control Office Application (COA)** so that only those trains (Coaching/Goods) which are running on the sectional boards of the Division are visible/reflected on the CMS module. This will ensure booking of train managers by the Crew & Guard Lobby only in those trains which are actually running in the sections.
2. Provision of Bio-Metric based SIGH ON/OFF must be ensured.

In view of the above, it is requested that feasibility/provision of integration of CMS and COA and installation of Bio-Metric device for Sign-on/Sign-off by the running staff be carried out.

Action take in this regard may kindly be advised to this office.
